## EXACT Report on Oberseminar (Prof. Wessels)

The EXACT PhD course "Oberseminar - Deepened analysis of research on European integration" took place in Cologne from October 2010 to February 2011. The Oberseminar, which was conducted in the context of the Cologne Graduate School (CGS), provided PhD students with the opportunity to present their PhD research designs to Prof. Wolfgang Wessels, Jean Monnet Professor of the Department of Political Science of the University of Cologne, and fellow PhD students. Through in-depth discussions on the PhD outlines, the students got the chance to acquire helpful input, remarks, critique and improvement suggestions by the class. Moreover, all participants of the course could deepen their knowledge on current research on European integration and expand their expertise on theories and methods of EU research and their application on relevant issues concerning the academic debate on EU research.

To fulfil the course criteria, students were required to give an oral presentation on their research project (see table below). Moreover, each student had to prepare a detailed comment on the presentation of fellow students.

As a special offer to the PhD students, Visiting Scientists of the EXACT programme, were requested to hold a presentation on current up-to-date research in EU affairs. Through the presentations of experienced international academics, the PhD students obtained valuable insights into post-doctoral academic work at academic as well as professional institutions. Accordingly, Prof. Ramses Wessel of the University of Twente, the Netherlands, Prof. Alfred Tovias of the Hebrew University Yerusalem, Israel, Dr. Anne Faber of the Europa-Universität Viadrina in Frankfurt (Oder) presented current examples of their own research. Alfred Tovias for instance held a guest lecture on free trade in services in the context of the Barcelona process.

As a résumé of the course programme, the PhD students agreed that they received beneficial feedback on their own research while simultaneously enhanced significantly their knowledge about other theoretical and empirical approaches to study EU politics.
