## "A changed Europe?" - TEPSA Conference in Copenhagen

EXACT fellows Several participated in the TEPSA Pre-Presidency Conference held from 8-9 December 2011 at the Danish **Institute for International Studies** (DIIS) Copenhagen. With in its regular conferences at the beginning of each new EU Council Presidency, the TEPSA network feeds the proposals of European think tanks into the presidencies' policy agenda.

Nanna Hvidt, the Director of DIIS, opened the conference. In her introductary remarks, she gave an overview of the goals that the Danish Presidency should pursue. This was followed by a keynote address by Per Fabricius Andersen, Deputy Head of Department at the Danish Ministry of Foreign Affairs. In his speech, he highlighted the challenges the Danish Presidency is likely to face given the difficult socioeconomic and political environment within and outside the EU and how the Presidency could handle them.

The conference afterwards discussed six recommendations

for the Danish Council Presidency TEPSA elaborated by the network of European think tanks. recommendations cover These improvements to the governance of the euro zone, considerations on multi-speed Europe and the financial perspectives, on the EU's external policy, enlargement and the Eastern Partnership and on the environmental and climate negotiations.

Two workshops considered the reform of the Common Agricultural Policy and differentiated membership of the EU, while three plenary sessions focused on the EU budget as a driver for growth towards achieving the Europe 2020 goals, the future of the Euro and the EU and the "Arab Spring", respectively.

The PPC conference also featured an interview session with Niels Helveg Petersen, former Danish Minister of Economic Affairs and former Minister of Foreign Affairs and Richard Youngs, Director General at FRIDE. This interview session considered Europe's Crisis and the **continued on page 2**

## EXACT Fellows participate in FIIA panel on the EU and its Neighbourhood

In September 2011, four EXACT Finnish fellows visited the Institute of International Affairs (FIIA) to participate in a workshop on 'The EU and its Neighbourhood Current Challenges and Conflicts'. The initiative was taken by the EXACT fellow Marlene Gottwald, who was at that time working in Helsinki. Together with her colleagues from FIIA she organised a very interesting programme, also giving the opportunity to meet local researchers and visit the Finnish Parliament.

The workshop was divided in two sessions: the Eastern and Southern dimension. In the former session EXACT fellow Marco Siddi spoke about protracted conflicts in the post-Soviet space and EXACT fellow Vanessa Boas discussed EU-Belarusian relations. They received helpful comments from Mrs Kristi Raik, a FIIA expert on the EU's Eastern Neighbourhood. The discussions showed the difficulties the EU has in creating leverage to respond to the challenges in the East.

In the second session, the EXACT fellows Leonhard den Hertog and Niklas Helwig presented some of their research on respectively the EU's reaction to the migration movements from North Africa following the 'Arab Spring' and the response of High Representative Lady Ashton to the revolution and unrest. Both presentations indicated that Europe's response had been divided and dominated by different, and sometimes opposing, forces in Brussels and the European capitals. They received excellent comments by Mrs Eija Rotinen, also FIIA researcher and former ambassador.

Additionally, the EXACT fellows had the possibility to attend Prof. Andrew Moravcsik's lecture, who was invited to give a speech at the European Studies Day at the University of Helsinki.

## Exact Fellows attend Graduate Conference in Jerusalem

In December, five EXACT fellows participated in the 7th Annual Graduate Conference at the Hebrew University in Jerusalem. The conference gathered PhD students from all around the world, who discussed and exchanged their research results. Vanessa Boas and Dana Depo participated in a workshop on the Political Economy of Transition in the Middle East and North Africa, while Niklas Helwig, Leonhard den Hertog and Miguel Seco contributed Haubrich to a panel on the European Union as a Global Actor.

The intensive workshop created a space for fruitful discussion and exchange of ideas as the group was small and the participants very advanced in their research. The workshop was led by Prof. Etel Solingen from the University of California, Irvine, and Prof. Alfred Tovias from the Hebrew University (and EXACT Visiting Scientist). Both provided us with a number of individual practical advices and academic encouragement. As a result, the one day workshop has brought us intensive feedback on our work, academic friends, and inspiration to continue.

While shorter in length than the workshop, also the panel on the EU as a Global Actor characterised the was by level of the feedback high and comments provided bv the two commentators. It is certainly this level of commitment and informed assessment that makes the graduate conference at the Hebrew University a worthwhile and rewarding visit for any PhD student.

Apart from the conference, the visit to Israel and the Occupied Palestinian Territories allowed us to get to know better one of the regions with most influence on EU foreign policy.

#### THESEUS Conference - Revive or Divide Europe? Marlene Gottwald

The EXACT fellows currently working at TEPSA - Nicole Koenig, James Nyomakwa-**Obimpeh and Marlene Gottwald** - provided background papers for a conference that assessed the current state of the EU and how to leave the murky waters of the crisis. The conference took place on 24-25 November as part of the THESEUS project and was organised by the Jean Monnet Chair of Prof. Wessels under the responsibility of Mirja Schroeder.

The THESEUS event brought together academics and

practitioners from across Europe to discuss current and future challenges for Europe. Renowned speakers as A. Grosser, B. Kohler-Koch and H. Wallace analysed the Franco-German leadership, how to solve the sovereign debt crisis affecting the Eurozone, the new institutional balance within the EU and the EU's external action two years after the entry into force of the Lisbon Treaty.

Significantly, most of the discussions were driven by the consequences of the crisis in the Eurozone which continues to be the greatest challenge for

the EU - affecting almost every field of EU policy-making in- and outside the Monetary Union. Closing two days of intensive and lively discussions, the concluding remarks by Prof. Jacqué and Prof. Wessels summed up the debates in one essential question on the future of European integration: "Revive or divide Europe?"

## **EXACT Network Seminar** on Professional Skills

A researcher at an early stage of his or her career needs to develop a whole range of skills to be successful. While profound research remains essential, the requirements for the job market of young researchers have broadened. Ideally, they need to be able to communicate their research via various channels, to apply for funding and to manage large scale research projects. Boosting those and others skills was the purpose of a 14-day seminar in collaboration with the Trans European Policy Studies Association (TEPSA) held in Brussels last October. Eight additional participants from across Europe joined the twelve EXACT fellows for the intensive training.

The two weeks schedule was filled to the top with assignments and sessions on inter alia policy brief writing, project funding and organisation, job interview training and personal development.

"We wanted to give the participants the opportunity to learn directly from the practitioners that have been around in Brussels and in the research community for decades", explains Hanna Ojanen from the Finnish Institute for International Affairs, Exact Visiting Scientist and Scientific Director of the seminar. "The feedback of the students and the reactions of the lecturers show that this was a fruitful exercise for everyone involved."

Indeed, the discussions with the 'old hands' of the business, like Antonio Missiroli, Angela Liberatore, Graham



Avery (all European Commission), Rafal Trzaskowski (MEP), Peter Burgess (Peace Research Institute Oslo) or Hiski Haukkala (University of Tampere), gave valuable insights into future work environments.

A highlight for the participants was the two-day media training carried out by the former speaker of Javier Solana, Cristina Gallach, in collaboration with radio journalist Kurt Gerhard (WDR). The group could make use of the premises and TV studios of the Commission. European Parliament and the Council to simulate expert interviews and press conferences. The instant feedback as well as the experiences shared by the trainers helped to improve the communication skills of the participants.

This EXACT network seminar focused on professional skills. It will be followed by a seminar focusing on academic skills in fall 2012.
